TERMS & CONDITIONS (Revised 2/25/10)

Objective:

As a collector of 35 years and Licensed Firearms Dealer since 1989 I have a clear definition of a satisfactory transaction. I will be paid as we agreed to, and you will be satisfied with your purchase. My goal is to establish a client list of satisfied repeat customers who will recommend me to other collectors. It's just that simple.

Exiled Saudi princes with secret funds needing change from an over paid purchase need not apply.

Notice:

ALL Federal, State, & Local firearms laws will be followed. I will take NO shortcuts in the process of a legal sale or transfer, so please don't ask.

Availability:

All items are in stock and available for immediate shipment. Please call or email and an Item will be held up to a week with your Name, Address, & Phone Number. Items marked *Reserved* are being held for awaiting payment or on layaway. If you are interested in a reserved item, please call or E-Mail to be placed on a backup list.

FIREARMS:

Modern firearms, post 1898, can only be shipped to a Type 01 Federal Firearms License address. Curio-Relic firearms, as defined by the BATF list, can usually be shipped to a Type 03 Collectors License address. Some states have additional restrictions such as CA, CT, DC, IL, MD, NJ and NY.

A signed valid license copy either mailed or emailed will be required for shipment to only the license address.

Antique firearms, pre 1898 do not require a Federal License. For purchase, a copy of the <u>'Purchase Certification'</u> and a copy of a Government Issued Identification (Drivers License, Etc), showing date of birth and current address will be required.

GUARANTEE:

Your complete satisfaction is assured, see objective above. If you are not satisfied, please contact me within 3 days of receipt. Please don't fire the weapon, safety, function and accuracy are NOT Guaranteed. Any weapon offered by Beaver Creek Arms is never test fired nor is there any representation the gun is functional and safe to fire. These guns are sold for collectors and only represented as used firearms that must be checked by a competent person, observe all the necessary safety precautions prior to attempting to load and fire one of these weapons **RETURNS:**

Returns must be made within 3 days of receipt. They must be received in exactly the same condition with no parts exchanged. If it has been altered, damaged, or fired, a refund will not be made. Packing, shipping and insurance cost will not be refunded. All layaway purchases are returnable for merchandise credit only.

Sales:

All sales are made with the buyer's full acceptance of the stated terms of sale. All sales are made in strict compliance with all Federal Firearms Laws. No items contained in this web site are offered for sale where prohibited by any Federal, State or Local laws. By ordering, the buyer certifies that their purchase will be in full

compliance with all Federal, State and Local laws. All transactions shall be deemed to occur in Pennsylvania regardless whether by telephone, mail, internet or the physical location of the buyer. All transactions will be subject only to Federal and Pennsylvania State law. Any disputes will be resolved in a Pennsylvania Court. **SHIPPING:**

Normally shipments are made via U.S.P.S. Priority Mail, Insured, with a return receipt. Typical Packing, Shipping and Insurance cost for a handgun is \$30.00, and for a Long Gun is \$40.00.

PAYMENT:

Western Union Wired U.S. Funds, Bank check, Personal check, and Money Orders are preferred. Visa and MasterCard are accepted with a 3% processing fee. For Visa and MasterCard orders please provide the account number, code number, expiration date, name on card, phone number and card billing address. This information can be phoned in, or E-Mailed. All orders must be paid in advance, C.O.D. orders are not accepted. Checks, both Bank and Personal must clear before the order will be shipped, usually a 2 week delay.

LAYAWAYS:

A 20% deposit is required. Balance is due in 60 days. Deposits are non-refundable and are forfeited after 60 days. Layaway sales are returnable for merchandise credit only.

SALES TAX:

Pennsylvania state sales tax is 6% for in state purchases. The payment of other states sales tax, if applicable, for shipped items is the buyers responsibility. **DISCREET:**

Client information will remain Confidential. Your privacy is protected.

EXPORTS:

A U.S. state department export license is required for all foreign purchases of modern firearms and restricted items. Our Export Agent is Mr. Walter Kanzler, P.O. Box 343, Key Largo FL 33037. Phone: (305) 451-2463. Fax: (305) 453-9645. E-Mail: WaffenMstr@aol.com.

Upon receipt of payment in the form of Western Union wired U.S. Funds, and your contact information the firearm can be transferred to Mr. Kanzler for export processing. Please contact Mr. Kanzler for detailed information and his export fees.

Due to international administrative procedures export sales are final, no returns or refunds on export sales.
