GUARANTEE:

Your complete satisfaction is assured.

RETURNS:

Returns must be made within 5 days of receipt. They must be received in exactly the same condition as pictured and described on the website. If it has been altered and/or damaged, a refund will not be made. Packing, shipping and insurance cost will not be refunded. The buyer is responsible for filling cliams for lost or damaged items via the US postal service.

Sales:

All sales are made with the buyer's full acceptance of the stated terms of sale. that his/her purchase will be in full compliance with all Federal, State and Local laws.
